#### 54. TO RECEIVE AN UPDATE FROM THE CLERK

- i) Cycle racks have been installed on Village Square
- ii) Some of the trees donated through the Woodland Trust (20) have arrived Providing the school are ok, planting to be carried out by Wheatley Wanderers on Friday 2<sup>nd</sup>.
- iii) Meeting with Howe Trust, site could be used for a storage area, however planning permission would be needed for a temporary structure. Given that the local scouts group have received a negative response from planners, for the same site, the committee felt that this would not be possible.

  The alternative option of a secure container on local site was considered. The cost would be in the region of £1,800 per annum with a monthly agreement. This was agreed by the committee and to be included in the budget for following year. The Clerk confirmed that there were no containers available at the moment, but we could be placed on the waiting list.
- iv) Wall repairs in Church Rd Rec have been completed
- v) Insurance claim for leaf blower, committee were happy to purchase a replacement whilst the claim was going through.
- vi) Pole pruner purchased
- vii) Fencing removal at Wheatley Playing Fields. Contractors appointed
- viii) Fix my street Miller Rd.
- ix) Christmas Tree and lights.
- x) Safety surfacing for Cullum Rd Rec has been completed. Fencing has remained whilst grass seed establishes.

# 55. TO CONSIDER SPECIFICATION FOR REPLACEMENT FENCE AT WHEATLEY PLAYING FIELDS AND TO APPROVE TEMPORARY FENCING QUOTES.
