# 102. UPDATE ON MEETING HELD ON 14th FEBRUARY 2017

i) Chair's report on the SODC Planning Committee on 7<sup>th</sup> March regarding application **P17/S1865/FUL (The Railway Hotel development)** and consideration of a response to SODC regarding lack of attendance at recent site visit.

RB reported that only one SODC Councillor had turned up to the site visit. RB attended the SODC Planning meeting and spoke against the application as did a resident of Simon's Close. It emerged that amenity space does include the balconies on the development. After much discussion, the application was eventually approved (5 in favour, 4 against) subject to approval of the s106 agreement and the pedestrian crossing.

Disappointment was expressed by members that only one SODC councillor had attended the site visit and the chair of SODC Planning had not attended. It was agreed that a letter should be sent. **RB/Assistant Clerk to draft letter.** 

ii) **P18/S0138/LDP 7 Hillary Way** Wheatley OX33 1UY construction of new garage with attached store, with highway access to rear of property.

This application has been approved (notice received after the agenda was sent out). RB spoke to the planning officer regarding concerns about this as the previous planning application had been refused because creating access contributed to changes in character and appearance. Members feel that the access from this site near the Roman Road/Leyshon Road junction will add to what is already a dangerous and busy location but no further action can be taken because it comes under permitted development.
